UNDER THE COLORADO STATE DOME

Two months into the legislative session and we have already seen a high volume of bills that impact our industry - and continue to expect movement and introduction of additional legislation. Throughout the session, CBSA works to advance legislation that improves the business, workforce, and industry growth strategies in the state and address bills that could have a negative impact on the industry.

Of the bills introduced to date this session:

CBSA Supports

- HB19-1127, Lt. Governor Concurrent State Service
- SB19-006, Electronic Sales & Use Tax Simplification System
- SB19-059, Automatic Enrollment in Advanced Course Grant Program
- SB19-067, Rural Development Grant Program Creation

CBSA Opposes

- SB19-005, Import Prescription Drugs From Canada
- HB19-1131, Prescription Drug Cost Education

CBSA will continue to monitor a number of bills introduced this session to ensure any proposals or amendments put forward will not impede research or have unintended consequences for the bioscience industry.

CBSA released new results from the state-funded Advanced Industries Grant program.

The Advanced Industries Grant program supports innovators and creates jobs. Colorado's economy, our bioscience companies, and the patients our companies serve all benefit from these critical investments. We look forward to working with legislators to keep our economy strong and support healthcare innovation. Since inception, the state Office of Economic Development and International Trade (OEDIT) has awarded more than 400 Advanced Industries grants to Colorado bioscience companies.

The program makes a significant impact in the state, creating:

- 79 new life science companies
- 773 direct jobs
- \$551.7 million in follow-on grants and investments in bioscience companies

Similarly, the Advanced Industry Investment Tax credit has created great opportunity for our industry Since program inception, the Advanced Industry Investor Tax credit program has encouraged 97 investors to invest \$7,164,075 in 24 bioscience companies.
