Violating these rules may result in your removal from the forums. The following Policies and Guidelines apply to "public" threads, private messages, visitor messages on user profiles, social groups, and any other form of communication within the CO Life Sciences Connection Center.

CO LIFE SCIENCES CONNECTION CENTER GUIDELINES AND POLICIES:

1. **Be Respectful:** Personal attacks, hateful, racially or ethnically derogatory comments, and harassment against other participants in the community will not be tolerated. You can certainly disagree with another user, but be respectful and keep your comments relevant to the topic of conversation.
2. **Avoid Nasty Language:** Foul, obscene or sexually explicit language or other content that a reasonable person would find objectionable is not permitted.



3. **Don't Spam:** Advertisements, solicitations or promotions will not be allowed
4. **Use Your Own Words:** The distribution of intellectual property not belonging to you is not permitted. Another way of saying it: speak your mind but use your own words to do so.
5. **Make Yourself at Home:** Remember, this is your community. Don't be shy to chime in and interact with your fellow CO Life Sciences Connection Center members. Feel free to express yourself, ask questions and mix it up.

CO LIFE SCIENCES CONNECTION CENTER DISCUSSION AND COMMENT GUIDELINES:

These are guidelines we enforce to ensure exchanges are informative, respectful of diverse viewpoints, and lawful. Contributions to the discussion boards will be posted automatically. Blog comments are moderated and are reviewed by a Colorado BioScience Association editor. CBSA may choose not to post or to remove the comment if it does not meet our comment guidelines. CBSA does not assume any liability for content posted by others. CBSA reserves the right to delete any message under circumstances that, in CBSA's judgment, is inappropriate, unlawful or otherwise detrimental to the community dialogue, such as the following:

- Personal attacks, hateful, racially or ethnically offensive or derogatory content, and harassment or threats against other participants of the discussion board, in the blog comments area or featured speakers on the site will not be tolerated. This includes libel or unsubstantiated accusations against another.
- Foul, obscene or sexually explicit language, and other content that a reasonable person would find objectionable will not be permitted.
- The distribution of intellectual property not belonging to you is not permitted. You must have the legal right to upload or download any content you upload to or download from the discussion board and/or blog comments. - Duplicate postings or messages in the wrong discussion box or blog comments (i.e. mismatched to the topic for that page) will be deleted or moved.
